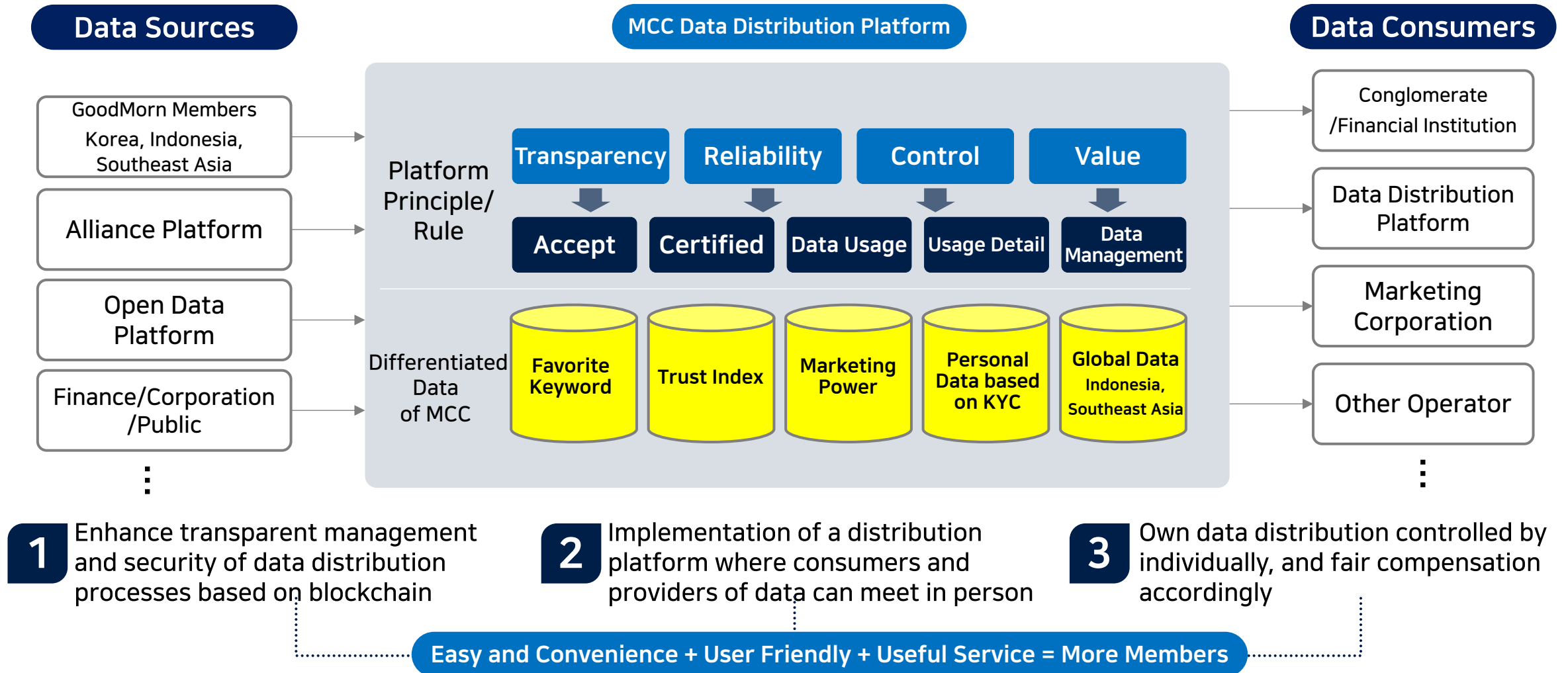

MCC is Creating a 'New Data Distribution Ecosystem'

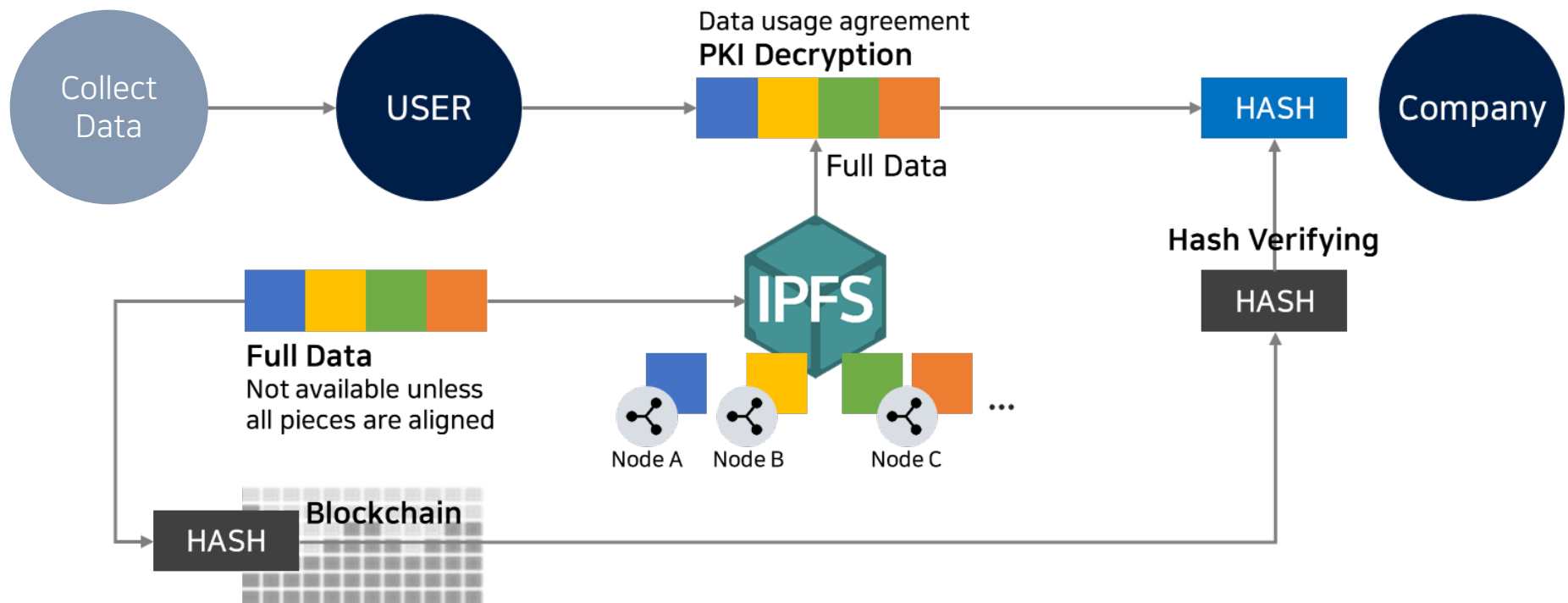
- MCC started with these Catchphrases

- Blockchain/crypto-based platforms have been implemented with MCC's own technology, which collects data from various sources and gives commercially available value.

Secured Transparency and Security Based On Blockchain

- All content is encrypted and recorded in the blockchain, and personal data is dispersedly stored in the hyper-ledger cloud.
- Encryption key is only stored on the user's own mobile and only the owner has access to own data

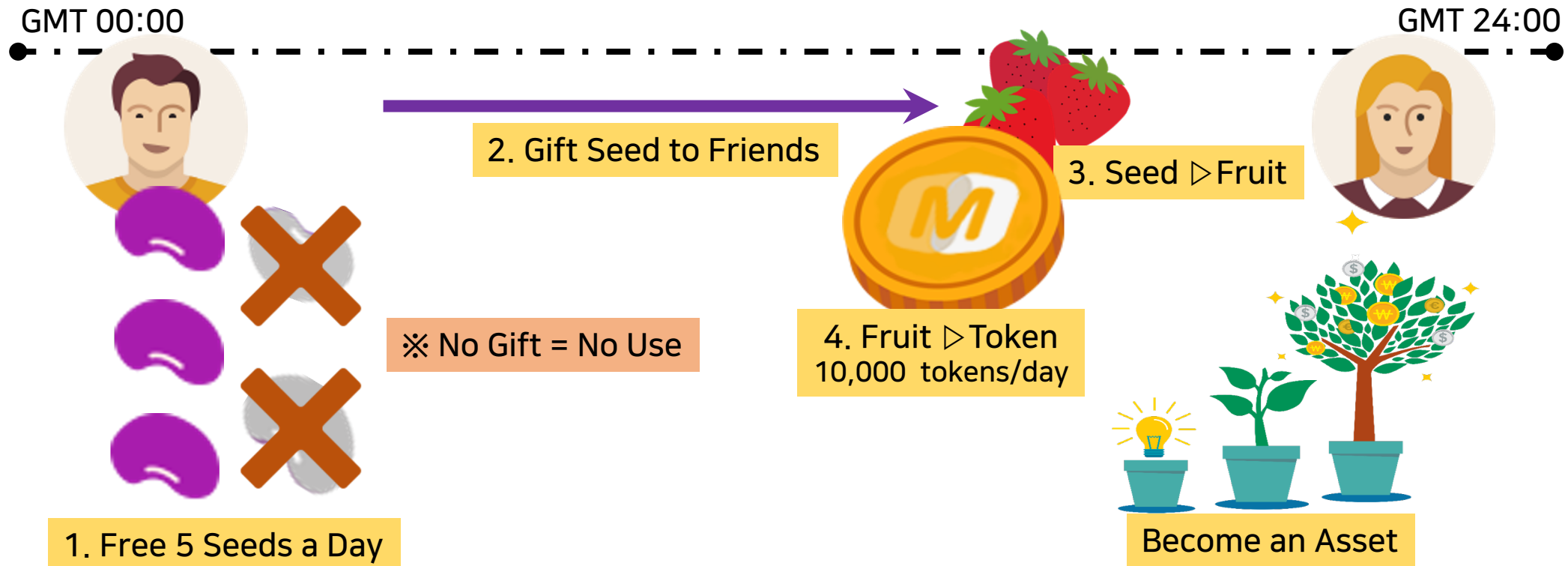

MCC Made Its Own Service, GoodMorn DAPP

- 'GoodMorn' DAPP was released to not only link data held by other companies, but also to secure differentiated data from user pools through MCC's own platform.
- "GoodMorn" is a user-friendly Market Entry Service for building a data distribution platform and it uses a patent called "Seed Gift."

Seed Gift Applied to GoodMorn is P2P Daily Air Drop

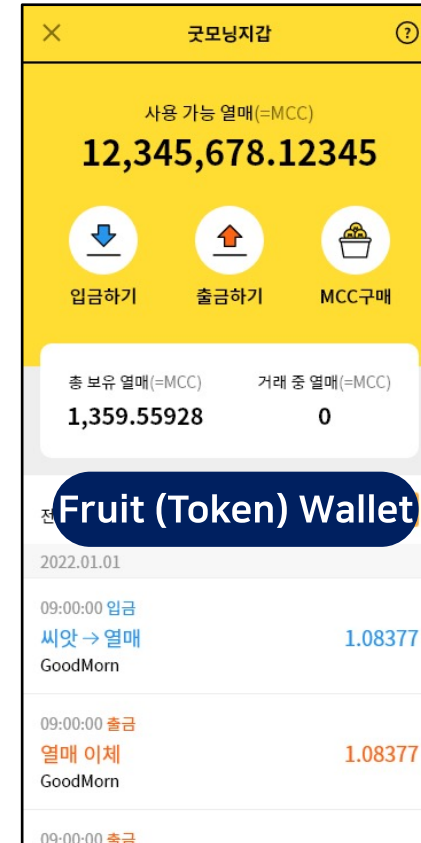
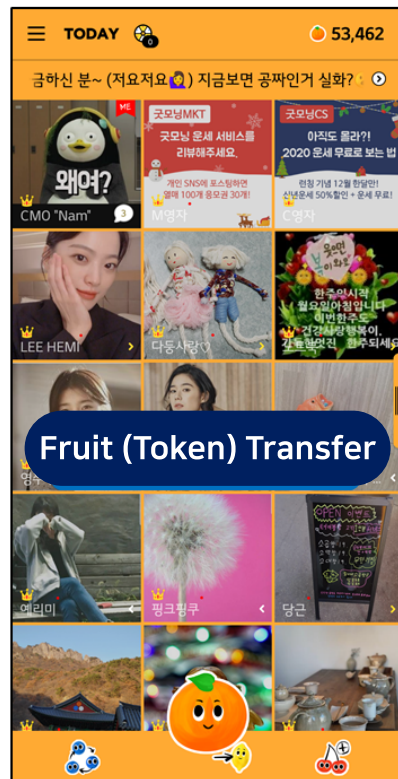
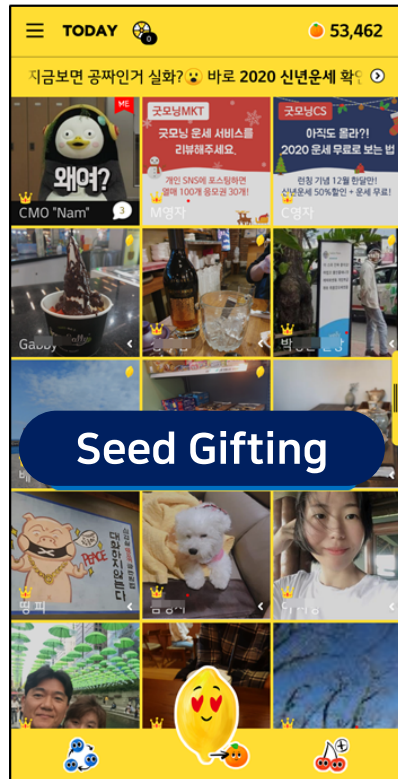
- Differentiated user incentives for GoodMorn DAPP, which has been patented, and a new type of mining
- As a result of analyzing GoodMorn's 220,000 users' data, gift-based networking is an innovative methodology that can infer the credit index between participants (Seoul Univ.)
- The "Friendship Network" between members and the individual's "Marketing Impact Map" will be collected and used as differentiated data for MCC



GoodMorn is a User-Friendly Market Entry service for Data Distribution Platforms

- GoodMorn provides services that give joy and economic benefits such as seed gifts and fruit transfers, wallet functions, roulette, charging station (Ads), and fruit bidding
- In Mar. 2022, "The Highest Fruit Bidding (competitive bid for the most bidders)" has been added, and is expected to expand to trendy product transactions that appeal to MZ generation, such as linking exchange prices and fruit in-app payments
- Planning to progress "NFT Version of Fruit Bidding"

GoodMorn Gathered 330,000 Members From Korea and Indonesia

- In Apr. 2019, the service was opened in Indonesia, but after the pandemic, the service changed target to Korea in May 2021.
- As of Mar. 2022, achieved 100,000 domestic members and more than 10,000 people are active every day

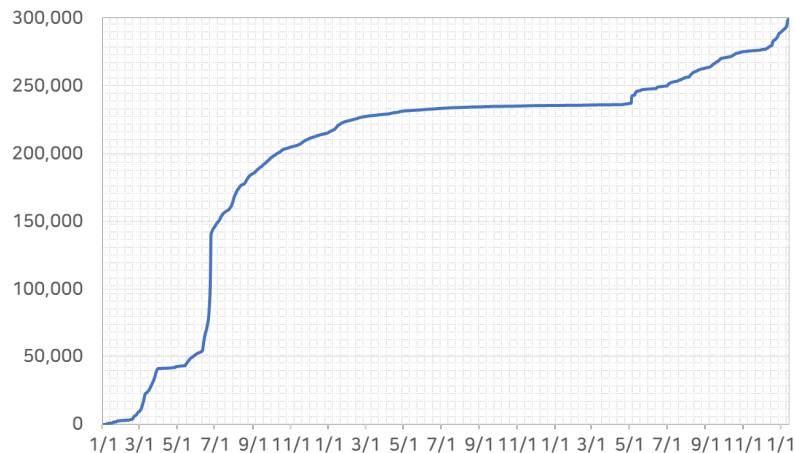

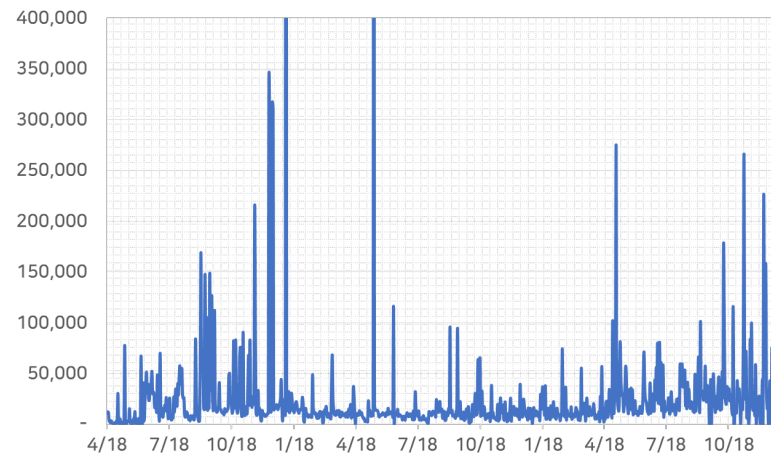

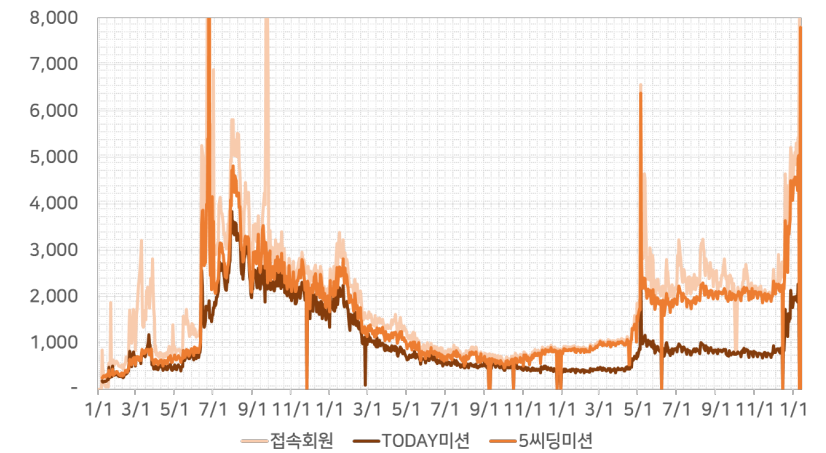

* DOS = Stable point of Dokdoverse / Rocks = Game points that aren't worth the money

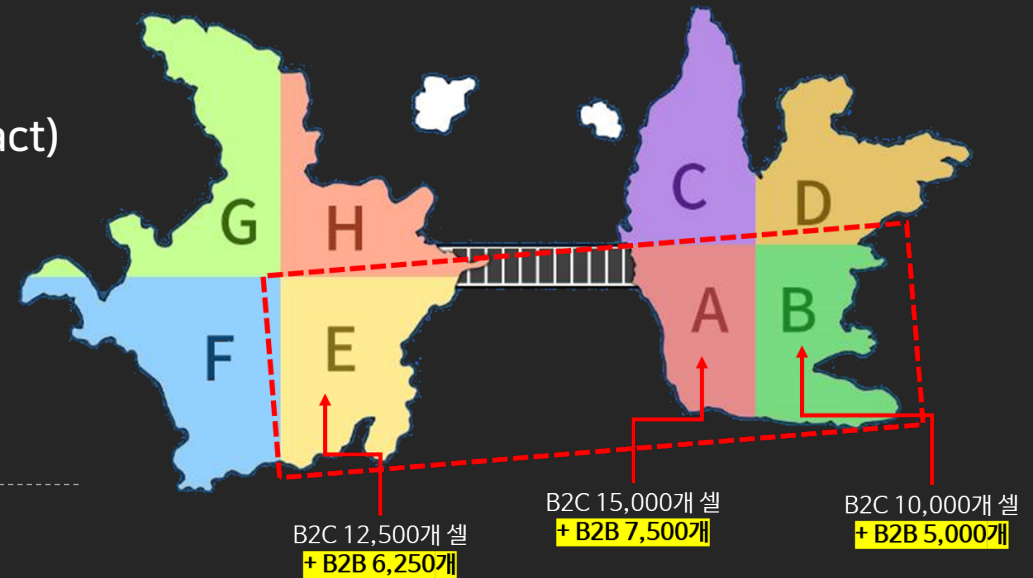
Advancement of Dokdoverse Platform

- **Prepare 8/15 Grand Open**
 - Pre-registration application > Close Beta Open (3/01) > Open Beta (End of June) > Grand Open (8/15)
- **Close Beta (Closed operation)**, implementation of functions such as Dokdoverse world, basic quest, acquisition of Dokdo certification, and issuance of NFT
- **Open Beta (New Membership)**, addition game functions such as quest advancement, expanded distribution of Dokdo certification, and added NFT items and fishing games

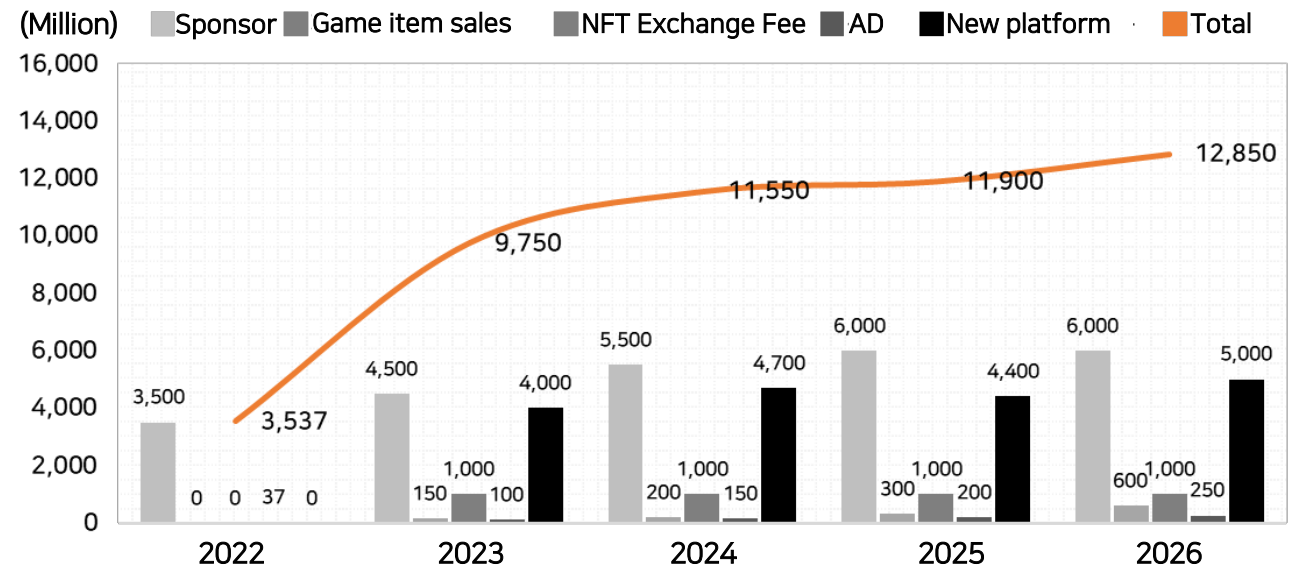
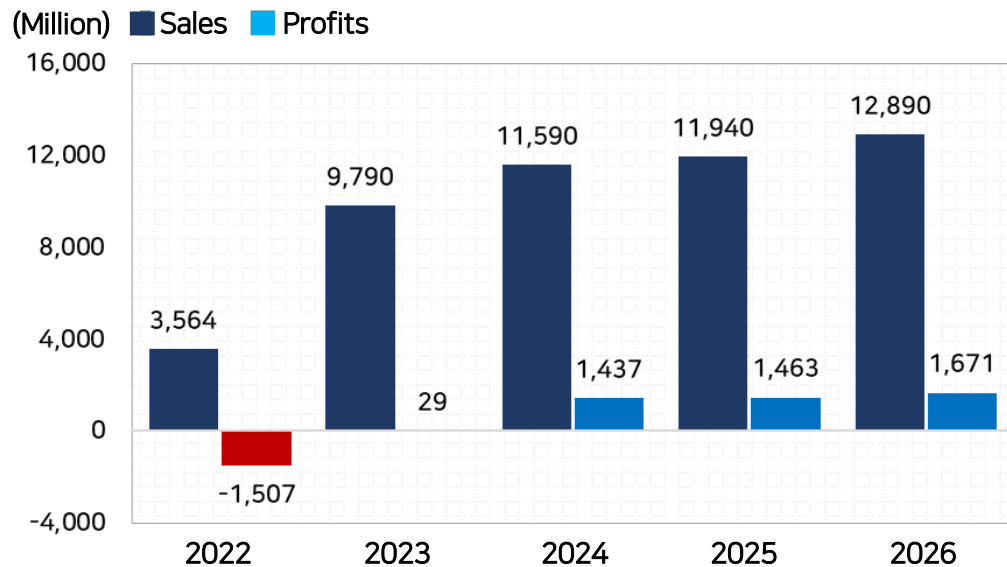


- **B2B Cell for Lease**
 - Dokdoverse consists of 100,000 cells and '50,000 B2B cells'
 - **Open a brand-only space in B2B cell, secure a metaverse business base**
 - Form a close relationship with providing various quests to members (provide various missions; view ads, quiz, dance brochure, visiting location, PPL avatar, etc.)
- **Establishment of New Metaverse Platform**
 - Business modeling and construction for companies that want to build their own metaverse/ NFT platform (Currently in discussion with various companies such as Korea Racing Authority, Samsung Life Insurance, KB Card, NH Bank Family)
 - Implementation of Mega-Verse that connects business ecosystem among established metaverse platforms

Sales and profit and loss estimation (5yrs)

“Achieve growth from 3.6 billion in 2022 to 12.9 billion in 2026”

Sales reached 12.9 billion won (1.7 billion won in operating profit) in 2026 through sponsorship of Dokdoverse, game NFT item, NFT distribution, and establishment of new metaverse



- Expenses for listing and operating MCC tokens were included in the sales and government expenses, but sales from the sale of tokens were not included
- Sales of NFT (30,000 units) in the provincial area belong to the Dokdoverse ecosystem as a budget for compensation of members
- Investment cost and revenue for global P2E games that will be co-vented do not include

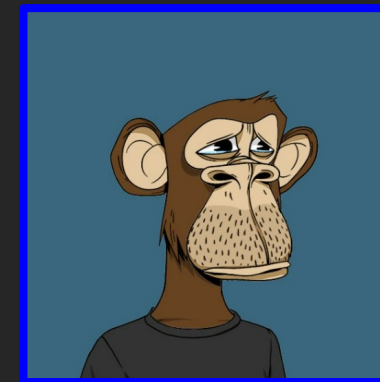

Purpose of attracting investment – Global P2E

Global P2E Game Line-up and MCC Ecosystem Application



• Grand War Battle (by X10 Games)

- “Military Deck Building RPG” (Current 80% Development Progress)
- Implementation P2E based on MCC token, GoodMorn Wallet, and NFT
- Enter Southeast Asia including Indonesia based on MCC Singapore branch
- Complete token distribution ecosystem by newly entering L-Bank (Singapore), Korean Exchange, and Indonesian local exchange where MCC tokens are listed
